

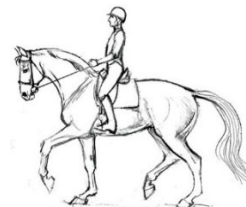

**General Information:**

1. Classes #4, 5, 6,7,8,9, 10, 11 &12 USEF/USDF Rules for Dressage competitions apply. Class 13: USAWE Dressage Rules Apply.
2. Dressage Attire. Western attire and tack for Class 13 or 14 only!
3. **Ride times will be emailed!** Ride times available **after 8:30 pm** on **Thursday July 6th**, or by calling (858) 243-1953
4. **Mgmt. reserves the right to cancel, split or combine classes.**
5. **Drug Fee (\$14.00), Grounds Fee (\$15.00) & CDS or CAWDA Fee apply to PVRA members and non-members alike.**
6. PVRA Members: Counts towards 2023 Dressage High Point. *Only one horse to count towards High Point-must declare which horse ahead of show; must ride 3 shows in series to qualify.*
7. Drinks available on the grounds. Dogs must be leashed.
8. Awards to First place, Ribbons to Sixth Place.
9. Grounds Open 6:45 am. Show starts 8 am.
10. **All short arena classes are ridden in a 20m x 40m arena.**
11. NO REFUNDS after closing date except with Vet Note.
12. Must Complete VSV Form (attached) on the day of the show.

**DIRECTIONS TO POWAY VALLEY RIDER'S ASSOCIATION:**

**From I-15:** Exit Camino Del Norte and Proceed East until it turns into Twin Peaks at the Poway City Limits. Stay on Twin Peaks and continue past Midland to Tierra Bonita. Turn Right. PVRA is two blocks down Tierra Bonita on the Right Side.

**Effective June 2023**

In light of the current outbreak of Vesicular Stomatitis Virus (VSV), **Poway Valley Riders Association is requiring all trainers, horse owners, and riders to sign this form to confirm that:**

- A. My horse(s) has not been near any positive cases in the last 14 days
- B. I have performed a full body check on my horse(s) and my horse(s) show no signs of any lesions, infection or fever
- C. I agree to the following Onsite Biosecurity Management Measures:
  - 1. I will avoid sharing water buckets or common water sources during the event.
  - 2. I will avoid the use of shared equipment and tack between riders.
  - 3. I will minimize exposure to fly vectors through the use of fly wipes, sprays, and other repellents for use on animals, applied as directed by label instructions.
  - 4. I will thoroughly fly spray the inside of my trailer before leaving for PVRA
  - 5. I will do proper manure cleanup and removal in and around my trailer spot.  
(Please bring your own muck bucket to take manure out)
  - 6. I will avoid close proximity with horses and humans from other barns.
  - 7. I will notify Show Management immediately if my horse starts showing symptoms during the event.

By signing this form, I assure Poway Valley Riders Association that I have assessed my horse's health, am confident that my horse is healthy and will take the above measures to minimize the chance of infection. I agree to hold Poway Valley Riders Association harmless if my horse subsequently comes down with the VSV after attending the horse show or event.
